- Till date more than 10 lady faculty have got benefitted through maternity leave.

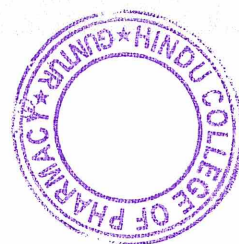

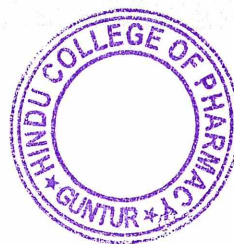
