ADMISSION PROCEDURE

B.Pharmacy (Bachelor of Pharmacy)

B.Pharmacy admissions are primarily based on the AP EAPCET (formerly known as AP EAMCET) entrance exam. Candidates need to qualify in the EAPCET exam and participate in web counseling conducted by the Convener AP EAPCET. 70% of seats are allotted based on the EAPCET rank, while the remaining 30% are filled by the management based on the EAPCET rank or merit in the Intermediate exams.

1. Eligibility:

- Candidates should have passed their 10+2 (Intermediate) exams with Physics, Chemistry, and Mathematics (MPC) or Physics, Chemistry, and Biology (BiPC) groups.
- A minimum of 50% marks in the qualifying exam is usually required.

2. Entrance Exam:

- The AP EAPCET exam is conducted annually by Jawaharlal Nehru Technological University (JNTU) on behalf of APSCHE (Andhra Pradesh State Council of Higher Education).
- The exam is conducted online.
- The application form for AP EAPCET is available on the official website cets.apsche.ap.gov.in.

3. Admission Process:

- **AP EAPCET Examination:**

Candidates need to register and appear for the AP EAPCET exam.

- **Counseling:**

After the exam results are released, candidates are called for counseling based on their rank.

- **Web Options:**

During counseling, candidates will be able to exercise their web options (college and course preferences) based on their rank.

- **Seat Allotment:**

Seats are allotted based on the candidate's rank, category, local/non-local status, and web options.

- **Reporting:**

Candidates who are allotted seats need to report to the respective colleges with the required documents for admission.

4. Required Documents:

- AP EAPCET Rank Card and Hall Ticket.
- Memorandum of Marks (Inter or equivalent).
- Proof of Date of Birth (SSC or equivalent).
- Transfer Certificate (TC).
- Study Certificate (from VI to Intermediate).
- EWS certificate (if applicable).
- Residence Certificate (if applicable).

5. Management Quota:

- In addition to the Convener quota (70%), 30% of seats are filled by the management of the college.
- These seats are usually filled based on the AP EAPCET rank or the merit in the Intermediate exams.

ADMISSION PROCEDURE

M.Pharmacy (Master of Pharmacy) – 5 Branches

1. Pharmaceutics

2. Pharmaceutical Chemistry

3. Pharmaceutical Analysis

4. Pharmacology

5. Pharmaceutical Regulatory Affairs

To get into an M. Pharmacy program in Andhra Pradesh, you generally need to qualify in an entrance exam like **GPAT** or the **AP PGECET**, and have a B. Pharmacy degree from a recognized institution. The selection process typically involves merit-based ranking from these exams, followed by counseling or direct admission to colleges.

1. Eligibility:

- A B. Pharmacy degree from a PCI (Pharmacy Council of India) approved institution is a must.
- You'll likely need a minimum qualifying percentage in your B. Pharmacy, often 50% or above.

2. Entrance Exams:

- **GPAT:** The Graduate Pharmacy Aptitude Test is a national-level exam that is often used for M. Pharmacy admissions.
- **AP PGECET:** The Andhra Pradesh Post Graduate Engineering Common Entrance Test is specifically for postgraduate admissions in Andhra Pradesh, including M. Pharmacy.

3. Admission Process:

- **Registration and Application:** You'll need to register and apply for both the entrance exam(s) and the specific colleges you're interested in.
- **Merit List:** Colleges will prepare a merit list based on your entrance exam scores and potentially your B. Pharmacy marks.



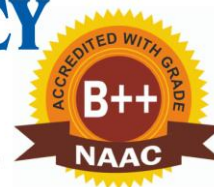

- **Fee Payment:** Finally, you'll pay the admission fee to secure your seat.

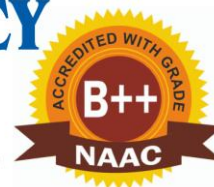

ADMISSION PROCEDURE

Pharm.D (Doctor of Pharmacy)

The Pharm.D (Doctor of Pharmacy) program in Andhra Pradesh generally involves an entrance exam like AP EAPCET for most seats, with the remaining filled through management or merit-based admissions. The Andhra Pradesh State Council of Higher Education (APSCHE) conducts the counseling for admissions based on the entrance exam rank.

1. Eligibility:

- Candidates must have passed their 10+2 examination with Physics, Chemistry, and either Mathematics or Biology as subjects.
- A minimum of 50% aggregate marks (45% for reserved categories) is usually required.

2. Entrance Exam (AP EAPCET):

- The AP EAPCET exam is conducted by [JNTUK](http://jntuk.org) on behalf of [APSCHE](http://apscche.org).
- It's a state-level entrance exam for pharmacy and other professional courses.
- Students are ranked based on their performance in the exam.

3. Counseling Process:

- [APSCHE](http://apscche.org) conducts web-based counseling for Pharm.D admissions.
- Candidates with valid AP EAPCET ranks participate in the counseling.
- They can choose their preferred colleges and courses based on their rank and seat availability.
- After seat allocation, candidates download the provisional allotment letter.

4. Admission Confirmation:

- Candidates must report to the allotted college within the specified time.

- They need to submit the provisional allotment letter and original documents for verification.
- The prescribed tuition fees must be paid to the institution.
- Upon successful completion of these steps, the admission is confirmed.
